**Agreements with Senior Professors BEFORE accepting the post of Vice Chancellor in-charge**

The senior professors who are willing to accept the post of Vice Chancellor in-charge of the University should agree to take up necessary actions to clean and reform the administrative and financial systems of Manipur University. The following actions should be taken as mandatory and first steps:

1. To put the condition on the concerned Governments that Prof AP Pandey should be removed as demanded by the Manipur University Community and public.
2. To put the condition on the concerned Governments that a high level and independent enquiry committee should investigate against Prof AP Pandey even after he is removed. If enquiry starts before removal of Prof AP Pandey from the Vice Chancellorship, he should be kept on suspension or forced leave till the enquiry is completely over with a conclusive end.
3. To put the condition on the concerned Governments that the enquiry committee should be an independent and secular committee, and therefore, members from the UGC and the MHRD should NOT be member(s) of the committee. Two independent members like Vice chancellor of a university and/or former Vice Chancellor of Manipur University should be appointed as members instead of members from the UGC and the MHRD.
4. To remove Prof M Shyamkesho Singh from the post of Registrar in-charge on the first day of joining as Vice Chancellor in-charge. New Registrar in-charge should be appointed. Prof M Shyamkesho Singh should be sent back to the concerned Department only for teaching and research. He should not also be allowed to continue as co-ordinator/chairman of any committee/centre or similar position, if any, except his personal funded research projects.
5. To transfer Dr. RK. Joteen Singh (Deputy Registrar) from present position to Library/ Examination Section/Guest House as Deputy Registrar or warden of hostel or equivalent.
6. To transfer Mr. David K Zote (Joint Registrar) from the present position to Library/ Examination Section as Joint Registrar or warden of hostel or equivalent.
7. All the academic Deans and Student's Dean who have tendered resignation recently should not hold any position like Dean/Chairperson/Director/Chief of any committee

such as Purchase Committee, Finance Committee, Library book/journal purchase committee during enquiry.

8. Any of the Dean who have tendered resignation recently should not accept Vice Chancellor in-charge.
9. If any Dean is being assigned presently as chairperson or similar of above mentioned committee(s), he/she should be removed from the position of chairperson or similar and the Vice Chancellor in-charge himself should be the chairperson of that committee.
10. The "Dean's Committee" which is not defined in the Manipur University Acts 2005 should be immediately dissolved.
11. In the enquiry, if any staff or faculty member is found involved in the academic and financial irregularities committed by Prof AP Pandey, action should be taken up against the staff(s) and faculty(ies).
12. Any level of security including "Y" Category Security or above should not be allowed to guard for protection of any officer including Vice Chancellor, Vice Chancellor in-charge or Pro VC of the University in the premise of Manipur University.
13. The office rooms of the new Vice Chancellor in-charge and Registrar in-charge should be arranged to new rooms other than the present rooms of the said above including computer rooms wherever applicable (during enquiry).
14. All the steps of investigation/enquiry against Prof AP Pandey should be accompanied by representative(s) of MUTA, MUSU and MUSA.
15. The present VC and Registrar rooms should only be unlocked for investigation/enquiry in the presence of representative(s) of MUTA, MUSU and MUSA.
16. Any file/letter (directly or indirectly related to Manipur University) which are brought back/returned to the Manipur University just before and during investigation/enquiry should be allowed to be marked on top/bottom of the file/letter by the representative(s) of MUTA, MUSU and MUSA for identification.
17. Movement of any file from the present VC's, Registrar's, Joint Registrar's and Deputy Registrar's should be allowed to be monitored by the representative(s) of MUTA, MUSU and MUSA for identification.
