The instant writ petition was filed requesting rescinding / cancelling the Memo No 119(24)/CM & AS/52/2(Part-II)/PBSSM/2020-21 dated 30.06.21.

Please find enclosed herewith a copy of the order dated 24.08.2021, passed by Hon'ble Justice Abhijit Gangopadhyay in the instant writ petition. The operative part of the order is as under:-

..... I will request the State respondents through learned Advocate General to issue schedule of work for others also who have not started their work and also to tell his clients so that they can get the both doses of vaccine.

Learned advocate for the petitioners has prayed that in this situation of pandemic, which is not over at all any disciplinary action against them and also others (though they are not representing others) may not be taken.

In the same tune I will request the State through the learned Advocate General not to make their lives miserable by taking disciplinary action against them. Let them live in peace."

The petitioners' prayer is for rescinding/cancelling one Memo No. 119 (24)/CM & AS/52/2 (Part-III)/PBSSM/2020-21 dated 30th June, 2021. The petitioners' grievance is that they were not vaccinated and still one of them is not fully vaccinated. Some other para teachers are also there who have not been vaccinated fully. They have never said that they will not do the job of updating the child registration. They wanted some respite in this situation and they wanted some preference of vaccination, both doses.
